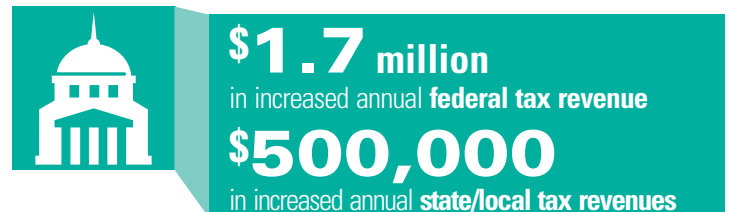
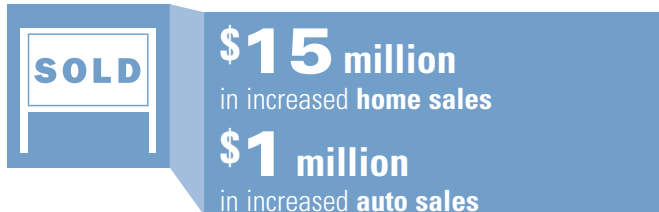
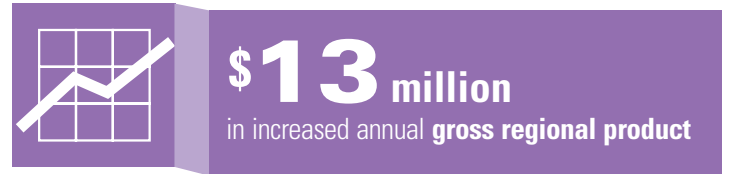
### WHAT IF ...
